NAERIC Draft Horse Classic Futurity

- This is one (1) event, consisting of three (3) divisions: Line Class, Pattern Cart Class, and Hitch Cart Class. Points from each judge are totaled to determine a winner.
- There will be three (3) judges. Judges will not confer on their placing. A tiebraker judge will be designated prior to the event. In the event of a tie, each tied entry receives, for each class, one (1) entry point, plus one (1) point for each horse the entry has placed above. The highest total tiebreaking points, of the tied entries, receives the higher placing.
- 3. The order of "go" will be determined by draw, at least one (1) hour before the start of the event.
- 4. The hitch cart class may be split; a drive off may be requested in the hitch cart class.
- 5. The winner of the Futurity will be the horse with the most points from the three (3) divisions.
- 6. Horses will be given one (1) point plus an additional point for each horse placing below them.
- 7. In the line class, horses will be examined walking and trotting between three cones/markers. A judge will be stationed at each of these points. Each judge may rework a maximum of three (3) horses without designation of which award they are being considered for.
- Horses must show in all divisions to receive prize money or an award. Once the exhibitor enters the ring he or she is considered in the class and does not lose eligibility for prize money if dismissed.
- The top ten (10) finishers of the Futurity must be available for presentations and pictures in the sale ring immediately prior to the start of the Sale.
- If fewer than 10 horses are entered in the futurity, purse money will only be awarded to the number of horses competing. The remaining purse money will be divided equally to all horses competing.
- 11. Every CONSIGNOR/NOMINATOR of a yearling to the Futurity and/or Sale must be a member of the NAERIC DRAFT HORSE CLASSIC. In addition, the breeder must be a NAERIC DRAFT HORSE CLASSIC member. The breeder is defined as the owner of the mare at the time of foaling, and the individual that registered the foal, based upon the breed association's registration certificate.

NAERIC DRAFT HORSE CLASSIC HALTER CLASS

Emphasis to be placed on an individual that is conformationally correct and sound on all feet and legs. Balance, breed type, form to function, smoothness of body parts, eye appeal and the action of the individual all to be considered. All breeds, all sexes, to show in the same class.

NAERIC DRAFT HORSE CLASSIC RAIL CLASS

Designed to show a free, easy moving individual that is relaxed, with alert ears, moving balanced with a non-intimidated, forward way of going, and bright and responsive to the driver at various gaits. All breeds, all sexes, to show in the same class.

Rail work, in both directions of the ring, will consist of walking and trotting. Judging will be based on the horse's overall performance and way of going as well as its ability to hold the designated gait. Action, headset, type and eye appeal all to count. Horses may be asked to back.

LADY DRIVER DIVISION

A maximum of \$1,250.00 added purse to be paid to the hi-point lady drivers. Eligible lady drivers must be listed as the registered owner or coowner with the breed association at the time of Futurity entry, and exhibit the three-year-old in all components of the competition. Up to four places will be paid out as: \$500.00, \$375.00, \$250.00, and \$125.00

FIRST-TIME DRIVER DIVISION

A maximum of \$1,250.00 added purse to be paid in the hi-point first-time drivers. Eligible drivers must exhibit the three-year-old in all components of the competition. Up to four places will be paid out as: \$500.00, \$375.00, \$250.00 and \$125.00.

NAERIC DRAFT HORSE CLASSIC PATTERN CART CLASS

Will consist of an individual pattern or work, designed to show how well broke the horse is.

- 1. Enter walk to pylon #1, trot circle. This element should reflect the performance of the walk, as well as determine soundness at the walk and trot.
- 2. Trot circle to the right around pylon #2, trot equal circle to the left around pylon #3.
- Stop, and pause, between pylons #2 and #3. This should be a complete stop for sufficient enough time to demonstrate the horse will settle completely.
- 4. Fan left 90 degrees, pause. Fan right 180 degrees, pause. Fan left 90 degrees, pause.
- 5. Exiting and Entering the cart. In a perfect maneuver the horse will not move and the driver will not use the lines to control any movement of the horse. Use of headman will be optional but taken into account accordingly in the judges' score.
- Driver, after exiting the cart, will pick up each foreleg demonstrating the horses willingness to have each foreleg efficiently and effortlessly checked.
- Entering and exiting the keyhole. Stepping on, breaking pattern, or stepping over the side rails (or rope) by either horse or cart will result in a zero (0) score.
- 8. Turn in the keyhole either direction. Stepping on, breaking pattern, or stepping over the rope or chalk line by either horse or cart will result in a zero (0) score.
- 9. Entering and Backing clear through the rails. Cart wheels must be completely past the rails prior to beginning the backup maneuver. Knocking down of a side rail will result in a zero (0) score.
- 10. Drive right and exit at trot. This element should reflect the performance of the horse at the trot during exiting, as well as determine the soundness of the horse at the completion of the pattern class.

Scoring is complete when you exit the arena.

Pattern only to be judged with emphasis on the correctness of each element and overall smoothness of the pattern. Speed is not the object. Elements to be judged at the three-year-old ability level.

SCORING GUIDE

1. Scoring for each maneuver is from 0 - 100, as follows:

Poor: 0 - 25 Fair: 26 - 50 Good: 51 - 75 Excellent: 76 - 100.

- 2. Penalties, per obstacle, to be given for the following:
 - 100 point penalty refusal, bucking, kicking and rearing.
 - Dismissal excessive abuse, horse or driver falling to the ground (driver's foot touching or horse's shoulder touching), excessive use of whip, or horse behaviour considered a danger to themselves or others.

EQUIPMENT

All horses are to be shown in standard equipment.

All drivers to show in appropriate attire.

warm-up arenas at all times.

Use of inhumane training devices and/or equipment will not be tolerated in the show arena or designated warm up arena, and will be cause for elimination from the competition. Horses and equipment are subject to examination by show management and/or judges in the show arena and designated

EXHIBITORS

Exhibitors may be changed as long as the Committee and the announcer are informed of the change at time of draw for "go" order, which is one (1) hour before the competition begins.

NAERIC DRAFT HORSE CLASSIC SALE

Statement of Purpose

- 1. Promote quality draft horses that are well conformed and will hitch/harness/drive well, have the capability to work and will look good when engaged in these activities.
- 2. Create an incentive to develop and train all horses in a humane manner, protecting at all times their physical and mental potential.
- 3. Promote resistance-free training methods resulting in a more efficient horse and to establish a greater market for good draft horses.
- 4. Provide an event that is enjoyable to spectators.
- 5. Provide an event that is beneficial to the draft horse industry.

GENERAL INFORMATION

SALE

Sale order will be determined by the Executive Committee.

BIDS

- The first yearling will be sold as "Buyer's Choice;" it will operate like this:
 - 1. All sale yearlings will assemble at the beginning of the sale.
 - Bids will be taken from all interested buyers for the right to have the first choice from all yearlings being sold.
 - 3. High bidder at the fall of the hammer will then make their choice and the yearling is "sold".
 - 4. The sale will begin again with the top of the sale order, as established by the DHC Executive Committee.
- The minimum opening bid will be \$1,000 per horse. The Auctioneer will accept all advancing bids, other than those considered to be irresponsible. The bidder offering the highest bid shall be the Buyer. In case of dispute as to the successful bidder, the horse shall again be put up for advance bids, and if there be no advance bids, the horse shall be sold to the bidder from whom the Auctioneer accepted the last bid. In all cases the Auctioneer's decision is final.

TERMS

- GST will be added to all purchases.
- Payment of the sale price shall be made in cash or cheque, payable at par at the sale location, unless satisfactory arrangements have been made prior to the sale. Buyers unknown to the Auction Company are required to bring a bank reference. Current exchange rate will be announced prior to the start of the sale.
- The right of the property does not change hands until full settlement is made.
- Auction Company reserves the right to require a certified cheque before any horse is released.
- Should any Buyer fail to settle for his/her purchase, the Auction Company reserves the full power to resell the horse to their best advantage, either privately or publicly, without further notice. Any loss resulting from such resale, and all other expenses arising from this, are payable by the original Buyer.
- The Buyer agrees not to stop payment on his/her cheque for any reason. A charge of \$50.00 (CAD) will be made on any cheque that is returned. All payment discrepancies will be dealt with to the fullest extent pursuant to Canadian law.
- All cheques should be made payable to "NAERIC Draft Horse Classic."
- Proceeds to Sellers will be payable by the NAERIC Draft Horse Classic (DHC) and will be mailed out as soon as Buyers' cheques clear the banks.

TERMS CONTINUED

- Settlement must be made no later than one (1) hour after the sale has concluded.
- Horses shall not be released to the Buyer until satisfactory settlement has been made.
- Each horse becomes the risk of the Buyer as soon as the horse is declared sold.
- Delivery is the responsibility of the Buyer.

The above terms constitute a contract between the Buyer and the Seller and shall be equally binding on both parties. Resale of the horse following the sale shall constitute a separate transaction and is not covered by the terms of this sale.

PAPERS

• It is the seller's responsibility to transfer the papers.

ERRORS

• Every effort has been made to assure correctness of the Sale Catalogue. The DHC Committee, NAERIC staff, and/or the Auction Company are not responsible for errors or omissions, and assume no liability on its part as to any statements regarding horses sold. Any error noted in the Sale Catalogue will be announced from the Auctioneer's stand. Any announcements from the Auctioneer's stand will take precedence over any matter in the Sale Catalogue.

LIABILITY

- All persons attend the Sale at their own risk. The DHC Committee, NAERIC staff, Royal Manitoba Winter Fair (RMWF) staff, and the Auction Company, and/or their/its representatives nor any other person connected with this sale assumes any liability, legal or otherwise, for the safety of the building or premises, for the behaviour of the horses, or for any loss or damage of persons or property.
- It is clearly understood the Auction Company is acting as agent between Buyer and Seller and is not responsible in any way for failure by either party to complete their transaction.

WARRANTEES

- The Seller has the responsibility to declare any known or observed defects in their horse(s). What is a defect to one person may not be a defect to another. Veterinary assistance, at the Buyer's expense, will be available on the RMWF show grounds.
- · All horses sell as sound unless otherwise stated. The Buyer has the responsibility to examine the horses carefully before bidding. Seller Declaration Forms will be available for inspection prior to bidding. Any known or observed illness, injury or defect will be noted and announced from the Auctioneer's stand prior to the sale of the horse. Buyers will have four (4) days from the time of the sale to notify the DHC if they feel that the horse has been misrepresented. This must be done in writing and be accompanied by a veterinarian's report (at the Buyer's expense) that the said injury, illness, or physical defect was present at the time of the sale, was not announced and did not occur after the sale. Cash, or a certified cheque, in the amount of a \$200.00(CAD) protest fee, must be made payable to the DHC. The DHC will then seek an opinion (at the DHC's expense) from the DHC's designated veterinarian. If the DHC's veterinarian agrees with the Buyer's veterinarian, the purchase price will be refunded to the Buyer along with the \$200.00 (CAD) protest fee, when the horse is returned safely to the Seller. If the Buyer's veterinary opinion differs from the DHC's veterinary opinion. the DHC reserves the right to obtain the opinion of a referee veterinarian

WARRANTEES CONTINUED

(at the Seller's expense). The majority veterinary opinion shall apply. In the event the sale of the horse is upheld, the \$200.00 (CAD) protest fee will be retained by the DHC.

- All warrantees terminate four (4) days (96 hours) from time and date of DHC Sale.
- The Buyer assumes full ownership and responsibility for the care and maintenance of said horse effective with the fall of the auctioneer's gavel.

TRANSPORTATION

 Assistance in making transportation arrangements will be provided when possible.

MAIL AND TELEPHONE BIDS

 Mail and telephone bids will be considered, but arrangements must be made prior to the sale.

INSURANCE




NAERIC Draft Horse Classic Futurity Pattern

- 1. Enter, walk to pylon #1, trot circle.
- Trot one circle to the right around pylon #2.
 Trot one equal circle to the left around pylon #3.
- 3. Stop, and pause between pylons #2 & #3.
- 4. Fan left 90 degrees, pause. Fan right 180 degrees, pause. Fan left 90 degrees, pause.
- Exiting & Entering the Cart (headman optional)
- Driver, after exiting, will pick up each foreleg.
- 7. Entering & Exiting the keyhole.
- 8. Turn in keyhole in either direction.
- 9. Entering & Backing clear through rails.
- Drive to the right of the rails, and exit at a trot.
