



NAERIC ROPING FOR CA\$H (2028 Futurity for Foals of 2024)

NAERIC-enrolled foals of 2024, bred by members of the Light Horse Marketing Group, (see membership list below) will be eligible for the 2028 4-year-old rope horse *NAERIC Roping for Cash Futurity*. The event will be held in conjunction with the Manitoba Rope Horse Futurity, traditionally held in September. To nominate your foal, complete the information below and submit/postmark to the NAERIC office (barb@naeric.org) NO LATER THAN December 31, 2024, along with the nomination payment of \$100 (CAD).

NAERIC will guarantee a purse of \$5,000 for this event to be split between heading and heeling. For every foal nominated after 50 head, NAERIC will match \$ for \$ up to an additional contribution of \$5,000, for a maximum contribution of \$10,000. All nomination money paid by owners will be added to the purse.

Example: 60 horses nominated = \$5,000 guaranteed + \$1,000 NAERIC additional match + \$6,000 owner nominations at \$100 per head = \$12,000 Total Purse.
